Scottish Water Procurement

When it comes to water competition, Scotland is ahead of the game.

While companies in England will have to wait until 2017 before they can switch supplier, Scotland has had this option since 2008. This isn't widely known; only 13% of Scottish businesses have reviewed their water procurement obligations. Many could be missing out on huge benefits; a switch of water supplier in Scotland typically reduces a water bill by 15%-20%.

Scotland's Water Market History



The retail water market for businesses has led to a significant increase in water efficiency. As a result, service costs have been cut by £10 million since 2008 as suppliers compete to provide reductions in bills and better customer service.

Business users are now able to choose the supplier that best suits their needs – however big or small their business and wherever their location in Scotland.

The new market brings an end to the 'one size fits all' approach. Benefits include more competitive pricing and increased focus on customer service.

How the Market Works

The market operates in much the same way as in other utility services where various suppliers compete for customers by offering them the best deal.

Suppliers buy wholesale services – the physical supply of water and removal of sewage– from Scottish Water (the former monopoly supplier). They then package them with other value-adding services for their customers at competitive prices. Scottish Water retains control of Scotland's publicly owned network of pipes and treatment works. It also continues to serve all household customers. 
